Acquisition of SPEKSNIJDER TRANSPORT in the Netherlands

STEF announces the acquisition of a 100% stake in the SPEKSNIJDER TRANSPORT company, located in Bodegraven (15 km north of Rotterdam). With this operation, STEF strengthens its position and broadens its transport and logistics services offer in Northern Europe.



Founded in 1982 and managed by Wilma Speksnijder, SPEKSNIJDER TRANSPORT offers logistics and groupage services across Benelux, operating from a bi-temperature 6 500 m² platform. SPEKSNIJDER TRANSPORT turnover for 2013 stood at M€ 13.5, with 117 employees and 73 vehicles. SPEKSNIJDER TRANSPORT is certified BRC S&D et ISO 9001:2008.

The quality of this company's real estate and commercial position makes is a real asset for STEF. It gives STEF a base in in the Netherlands which is immediately operational, and from which the Group will be able to develop its other activities. Moreover, the strong reputation of SPEKSNIJDER TRANSPORT will help STEF develop its export operations from the Netherlands.

With a groupage network for temperature-controlled products in Belgium, France, Switzerland, Italy and the Iberian peninsula, STEF can help manufacturers from Southern Europe to develop their business in the Netherlands, and Dutch operators more easily access markets in Southern Europe.
