STEF celebrates the 25th anniversary of its Chambéry site

On Thursday, October 3, STEF celebrated the 25th anniversary of its Chambéry site, one of the key elements of its transport and logistics system dedicated to food products in the Auvergne-Rhône-Alpes region. An event that brought together nearly 300 guests in the presence of Stanislas Lemor, Chairman and Chief Executive Officer of STEF, Marc Vettard, Deputy Chief Executive Officer of STEF, Patrick Mignola, Deputy of Savoie, and Xavier Dullin, President of Grand Chambéry.

The Chambéry site is the key partner of agrifood manufacturers, retailers and out-of-home foodservice in the Alps. More than 200,000 tons of fresh and frozen products are processed there every year.

To meet its development and better meet the needs of its customers, the site has recently been expanded with a storage space of more than 13,000 m³ at -25°C and an 80 m² freezing tunnel at -37°C for Savoie PGI raclette (protected geographical indication) and IST reblochon (secondary processing industry). For the transport part, the site has acquired new structures: reception / shipping quay, mezzanine storage on more than 1,500 m², a heavy goods vehicle workshop and a liquid fuel and nitrogen station.

In order to reduce the impact of its activities on the environment, the Chambéry site has a fleet of vehicles equipped with a cryogenic on-board cold production solution. Objective: vehicles with lower CO₂ emissions, silent, perfectly adapted to city centre delivery operations by day and night as well as mountain resorts.

Marc Vettard, Deputy Managing Director of STEF, said: "It is always a moment of joy to celebrate the longevity of a site, especially when it is associated with the opening of new equipment, proof of the dynamism of the activity. The success of the Chambéry site is based on a convergence of economic and political will to promote the Alps, its products and industries. Very attached to its local roots, our Chambéry site is committed to fully playing its role as a regional economic player and a key employer.
